Gift Aid

We can make more money for "The Mill" if you are a taxpayer and will complete the Gift Aid Declaration form below and return it to our Treasurer.

Under the gift aid rules there is **NO** minimum donation and no need for a deed of covenant or long term commitment if your circumstances change.

If you "gift aid" your donations, and sign the appropriate declaration, as a registered charity "The Mill" can recover 28 pence for every £1 donated, A donation of £100 is therefore increased to £128 just by signing the gift aid declaration.

To be able to reclaim tax on your gifts the Inland Revenue rules require:

- 1) You to sign and return to us the gift aid declaration.
- 2) Us to be able to identify gifts against specific individuals, i.e by either standing order payment or cheque.
